

Privacy Policy

LiveAbility South Australia Pty Ltd is committed to ensuring that privacy and confidentiality are protected. The Australian Privacy Principles set minimum standards covering the legitimate use of personal information. LiveAbility SA is committed to complying with those Principles.

In brief, LiveAbility SA only collects personal information:

- which is necessary for the lawful provision of services to members in accordance with the LiveAbility SA Ends Policies;
- which is given voluntarily; and
- which will be stored securely on LiveAbility SA's internal databases.

When in possession or control of a record containing personal information, LiveAbility SA will ensure that:

- the record is protected against loss, unauthorised access, modification or disclosure, by such steps as it is reasonable in the circumstances to take;
- if it is necessary for that record to be given to a person in connection with the provision of a service to LiveAbility SA, everything reasonable will be done to prevent unauthorised use or disclosure of that record.

LiveAbility SA will not disclose such personal information to a third party:

- without the individual's consent; or
- unless that disclosure is required or authorised by or under law.

Under no circumstances will LiveAbility SA sell or receive payment for licensing or disclosing personal information about employees or members. All employees and members of LiveAbility SA have the right of access to all records containing personal information about them. All inquiries or complaints about privacy should be directed to the Chief Executive Officer.
